GENERAL ADMINISTRATIVE

- Rehabilitation Programs Division staff attended the Public Awareness Corrections Today (PACT) Conference March 24, 2012.
- CIVIL COMMITMENT – During this period, 780 offenders were screened for Civil Commitment eligibility. The Multidisciplinary Team (MDT) met five times during this period (January 19, 2012 and January 20, 2012, February 16, 2012 and February 17, 2012, March 29, 2012), reviewing a total of 176 offenders for civil commitment. A total of 32 offenders were referred for expert assessments. During this time, there were ten (10) offenders that were civilly committed. Year to date stats for FY 2012 (September, 2011-March, 2012) are as follows: 2055 offenders screened for eligibility, 321 offenders have been reviewed by MDT, 65 have been referred for expert assessment with 24 being civilly committed. A total of 253 offenders have been civilly committed since the process began on January 1, 2000.
- DEOXYRIBONUCLEIC ACID (DNA) TESTING – During this period, 5,843 offenders were DNA tested.
- GIVING OFFENDERS' KIDS INCENTIVE AND DIRECTION TO SUCCEED (GO KIDS)
 - Since the last reporting period, 2,274 site visits to the GO KIDS website were recorded.
 - 12 phone calls, 16 emails were received.
- CHAPLAINCY DEPARTMENT
 - During this period, Chaplaincy staff attended the Southwest Texas Area (SWTA) 68 Annual Corrections Conference in Kerrville, Texas.
 - Chaplaincy Department staff attended volunteer appreciation banquets at the Henley State Jail and Plane State Jail.
 - Chaplaincy staff attended the Experiencing God Training with Texas Baptist Men in Huntsville, Texas, the Bill Glass for Life reception in Huntsville, Texas, Alcohol Anonymous volunteer training in Houston, Texas, the Less Than The Least volunteer appreciation dinner in Houston, Texas, and the Less Than The Least special event at the Wynne Unit
- VOLUNTEER SERVICES
 - During this period, Volunteer Services held 10 special on-site training/orientation classes for various ministry organizations, groups, or individuals for a total of 435 volunteers.
 - There were 74 training and orientation sessions held at regional locations accommodating 1,153 volunteer applicants or those needing to retrain.
 - Six hundred sixteen (616) volunteers used the retraining on-line feature to fulfill the two year retraining requirement.
 - Events aimed at promoting the TDCJ volunteer program, recognizing volunteers and volunteer programs for their service, and encouraging reentry program for offenders. Events included several meetings with Texas A&M Health Science Center for a new program on self-management of chronic health diseases, an introductory lunch meeting with Ron Brigmon Ministries, an introductory meeting with Houston Area Muslim volunteer groups, observing Southwest Seminary students at Darrington Unit, meeting with Truth Be Told Ministries Leadership team, attended a meeting with the board members of the Austin/Travis County Reentry Roundtable.
 - Volunteer Services designed and initiated a new format for the quarterly Volunteer Services newsletter.

- The current number of agency-wide approved volunteers at the end of March is 19,257*. This is a net gain (taking into consideration the removal of volunteers per previous bullet) from the previous quarter of 1,038 approved volunteers.
- Within this three month period, the average number of applications received per month was 894 with an average of 415 being received through the on-line application program.
- NEW VOLUNTEER PROGRAM PROPOSALS
 - 62 program proposals were received in January, 61 in February and 64 in March.
 - During this period, 187 proposals were approved, 0 not approved, 0 did not require approval, and 10 are pending review.
- WRAPAROUND
 - During this period, there was no Wraparound held at Plane/Henley State Jails. Resource facilities will be contacted to discuss how they can continue to serve the needs of the offenders.

PROGRAM ACTIVITIES

- BABY AND MOTHER BONDING INITIATIVE (BAMBI) – During this period, nine offenders and ten babies (twins) were received at Santa Maria. Five offenders and five babies were successfully discharged from the program; one (1) offender was removed for a Federal Bench Warrant.
- REHABILITATION TIER TRACKING AND PLACEMENT - During this period, 11,089 offenders were enrolled in Further Investigation - Rehabilitation (FI-R) programs.
- SERIOUS VIOLENT OFFENDER REENTRY INITIATIVE (SVORI) – During this period, there were 16 offenders that participated in the program and have been released. Eight of those offenders were voted by the Board of Pardons and Parole. The monthly enrollment average for this quarter was 66. There were five offenders removed from the program. There have been 631 offenders enrolled in Phase-I since the beginning of the SVORI program.
- SEX OFFENDER REHABILITATION PROGRAMS – During this period, 115 offenders successfully completed the Sex Offender Treatment Program (SOTP) and 245 offenders successfully completed the Sex Offender Education Program (SOEP).
- SUBSTANCE ABUSE TREATMENT PROGRAMS
 - In-Prison Therapeutic Community (IPTC)
 - During this period, 735 offenders were enrolled in the IPTC program and 691 offenders completed the program.
 - Pre-Release Therapeutic Community (PRTC)
 - During this period, 205 offenders were enrolled in the PRTC and 222 offenders completed the program.
 - Pre-Release Substance Abuse Program (PRSAP)
 - During this period, 298 offenders were enrolled in the program and 319 offenders completed the program.
 - Substance Abuse Felony Punishment Facility (SAFPF)
 - During this period, 1,425 probation offenders were enrolled in the program, and 1,258 probation offenders completed the program.
 - 164 parole modification offenders were enrolled in the program, and 159 parole modification offenders completed the SAFPF.
- DRIVING WHILE INTOXICATED PROGRAM – During this period, 256 offenders were enrolled 248 offenders completed the program.
- STATE JAIL SUBSTANCE ABUSE PROGRAM – During this period, 1,457 State Jail offenders have enrolled into the program, and 1,112 State Jail offenders have completed the program.

GENERAL ADMINISTRATIVE

- CIVIL COMMITMENT – During this period, 771 offenders were screened for Civil Commitment eligibility. The Multidisciplinary Team (MDT) met five times during this period (April 19, 2012 and April 20, 2012, May 17, 2012, May 18, 2012, and June 21, 2012), reviewing a total of 179 offenders for civil commitment. A total of 38 offenders were referred for expert assessments. During this time, there were nine (9) offenders that were civilly committed. Year to date stats for FY 2012 (September, 2011-June, 2012) are as follows: 2826 offenders screened for eligibility, 500 offenders have been reviewed by MDT, 103 have been referred for expert assessment with 33 being civilly committed. A total of 262 offenders have been civilly committed since the process began on January 1, 2000.
- DEOXYRIBONUCLEIC ACID (DNA) TESTING – During this period, 6,325 offenders were DNA tested.
- GIVING OFFENDERS' KIDS INCENTIVE AND DIRECTION TO SUCCEED (GO KIDS)
 - During this period, 2,639 site visits to the GO KIDS website were recorded.
 - 12 phone calls, 5 emails were received.
- CHAPLAINCY DEPARTMENT
 - During this period, Chaplaincy staff attended the Spring Regional Conference of the American Correctional Chaplain's Association (ACCA) in San Antonio, Texas to do a presentation on the Religious Land Use and Institutionalized Persons Act of 2000 (RLUIPA).
 - Chaplaincy Department staff, who were guest speakers, attended the Kairos State Board Meeting in Austin, Texas
 - Chaplaincy staff attended the Bridges to Life Board Meeting in Houston, Texas; the InnerChange Freedom Initiative Graduation at the Vance Unit; the InnerChange Freedom Initiative 15th Year Celebration in Houston, Texas; Chairman Bell was the guest speaker. Chaplaincy staff also participated in the Day With Dad program at the Vance Unit; and the Faith Based Dorm Graduation at the Plane State Jail.
- VOLUNTEER SERVICES
 - During this period, Volunteer Services held 4 special on-site training/orientation classes for various ministry organizations, groups, or- individuals for a total of 397 volunteers.
 - There were 70 training and orientation sessions held at regional locations accommodating 943 volunteer applicants or those needing to retrain.
 - Three Hundred eighty-nine (389) volunteers used the retraining on-line feature to fulfill the two year retraining requirement.
 - The current number of agency-wide approved volunteers at the end of June is 20,207. This is a net gain from the previous quarter of 950 approved volunteers.
 - Within this three month period, the number of applications received was 2,023 to include 853 received through the on-line application program.
- NEW VOLUNTEER PROGRAM PROPOSALS
 - During this period, 66 program proposals were received.
 - 130 proposals were approved and 8 are pending review.
- WRAPAROUND
 - During this period, there was no Wraparound held at Plane/Henley State Jails. Resource facilities will be contacted to discuss how they can continue to serve the needs of the offenders, there is a Wraparound scheduled for July.

PROGRAM ACTIVITIES

- BABY AND MOTHER BONDING INITIATIVE (BAMBI) – During this period, 8 offenders and 8 babies (one set of twins) were received at Santa Maria. Six (6) offenders and 7 babies were successfully discharged from the program.
- REHABILITATION TIER TRACKING AND PLACEMENT - During this period, 10,841 offenders were enrolled in Further Investigation - Rehabilitation (FI-R) programs.
- SERIOUS VIOLENT OFFENDER REENTRY INITIATIVE (SVORI) – During this period, there were 23 offenders that participated in the program and have been released. Seventeen of those offenders were voted by the Board of Pardons and Parole. The monthly enrollment average for this quarter was 73. There were five offenders removed from the program. There have been 660 offenders enrolled in Phase-I since the beginning of the SVORI program.
- SEX OFFENDER REHABILITATION PROGRAMS –
 - Sex Offender Treatment Program (SOTP) 18R
 - During this period, 100 offenders were enrolled in the SOTP 18R with 92 successfully completing the program.
 - Sex Offender Treatment Program (SOTP) 9R
 - During this period, 44 offenders were enrolled in the SOTP 9R with 18 successfully completing the program.
 - Sex Offender Education Program (SOEP)
 - During this period, 370 offenders were enrolled in the SOEP with 367 offenders successfully completing the program.
- SUBSTANCE ABUSE TREATMENT PROGRAMS
 - In-Prison Therapeutic Community (IPTC)
 - During this period, 755 offenders were enrolled in the IPTC program and 681 offenders completed the program.
 - Pre-Release Therapeutic Community (PRTC)
 - During this period, 165 offenders were enrolled in the PRTC and 254 offenders completed the program.
 - Pre-Release Substance Abuse Program (PRSAP)
 - During this period, 331 offenders were enrolled in the program and 342 offenders completed the program.
 - Substance Abuse Felony Punishment Facility (SAFPF)
 - During this period, 1,600 probation offenders were enrolled in the program, and 1,351 probation offenders completed the program.
 - 149 parole modification offenders were enrolled in the program, and 164 parole modification offenders completed the SAFPF.
- DRIVING WHILE INTOXICATED PROGRAM – During this period, 182 offenders were enrolled 170 offenders completed the program.
- STATE JAIL SUBSTANCE ABUSE PROGRAM – During this period, 1,506 State Jail offenders have enrolled into the program, and 1,166 State Jail offenders have completed the program.

GENERAL ADMINISTRATIVE

- CIVIL COMMITMENT – During this period, 554 offenders were screened for Civil Commitment eligibility. The Multidisciplinary Team (MDT) met six times during this period (July 19, 2012 and July 20, 2012, August 16, 2012 and August 17, 2012, September 20, 2012, and September 21, 2012), reviewing a total of 211 offenders for civil commitment. A total of 35 offenders were referred for expert assessments. There were nine (13) offenders that were civilly committed. Year to date stats for FY 2012 (September, 2011-August, 2012) are as follows: 3155 offenders screened for eligibility, 640 offenders have been reviewed by MDT, 126 have been referred for expert assessment with 43 being civilly committed. A total of 275 offenders have been civilly committed since the process began on January 1, 2000.
- DEOXYRIBONUCLEIC ACID (DNA) TESTING – 5,638 offenders have been DNA tested.
- GIVING OFFENDERS' KIDS INCENTIVE AND DIRECTION TO SUCCEED (GO KIDS)
 - There were 2,880 site visits to the GO KIDS website recorded.
 - 14 phone calls, 9 emails were received.
- CHAPLAINCY DEPARTMENT
 - RPD Administration and Chaplaincy staff represented TDCJ at the Celebrate Recovery 6th Year Anniversary in Houston at Lakewood Church. The TDCJ was recognized for their support of Celebrate Recovery throughout Texas.
 - RPD Administration provided training for Region I, II, III, and VI unit chaplains. Several Divisions participated to include: Victim Services, General Counsel, Executive Administration, and Texas Board of Criminal Justice Board Member Vice Chairman, Tom Mechler. The training was well received.
 - Chaplaincy staff participated in a professional panel for the Southeast Texas Area 67 (SETA) Correctional Facilities Committee (CFC) in Houston, Texas.
- VOLUNTEER SERVICES
 - Volunteer Services held 4 special on-site training/orientation classes for various ministry organizations, groups, or- individuals for a total of 215 volunteers.
 - There were 64 training and orientation sessions held at regional locations accommodating 873 volunteer applicants or those needing to retrain.
 - Four hundred thirty-five (435) volunteers used the retraining on-line feature to fulfill the two year retraining requirement.
 - The current number of agency-wide approved volunteers is *20,853.
 - Within this three month period, the number of applications received was 1,667 to include 836 received through the on-line application program.
- NEW VOLUNTEER PROGRAM PROPOSALS
 - During this period, 37 program proposals were received. Thirty Three (33) proposals were approved and 1 is pending review.
- WRAPAROUND
 - During the months of July-September there was one (1) WrapAround Resource Fair held at Plane/Henley State Jails. There were 33 offender participants and 11 vendors.

PROGRAM ACTIVITIES

- BABY AND MOTHER BONDING INITIATIVE (BAMBI) – During this period, 8 mother and baby pairs were enrolled in the program. One offender was removed and 8 offenders and 8 babies successfully completed and discharged from Santa Maria.
- SERIOUS VIOLENT OFFENDER REENTRY INITIATIVE (SVORI) – There were 28 offenders that participated in the program and have been released. 74 of those offenders were voted by the Board of Pardons and Parole and 1 Offender was a volunteer. The monthly enrollment average for this quarter was 75. There were 1 offenders removed from the program. There have been 688 offenders enrolled in Phase-I since the beginning of the SVORI program.
- SEX OFFENDER REHABILITATION PROGRAMS
 - Sex Offender Treatment Program (SOTP) 18R
 - 125 offenders were enrolled in the SOTP 18R with 59 successfully completing the program.
 - Sex Offender Treatment Program (SOTP) 9R
 - 132 offenders were enrolled in the SOTP 9R with 32 successfully completing the program.
 - 100 beds have been added at the Stringfellow Unit.
 - Sex Offender Education Program (SOEP)
 - 289 offenders were enrolled in the SOEP with 331 offenders successfully completing the program.
 - The SOEP at the Goree Unit are converting to FI-18R beds upon completion of the SOEP Classes.
 - The SOEP at the Hightower Unit are converting 84 SOEP beds to be shared by FI-18R and FI-9R programs, upon completion of the SOEP classes.
- SUBSTANCE ABUSE TREATMENT PROGRAMS
 - In-Prison Therapeutic Community (IPTC)
 - 737 offenders were enrolled in the IPTC program and 709 offenders completed the program.
 - Pre-Release Therapeutic Community (PRTC)
 - 163 offenders were enrolled in the PRTC and 181 offenders completed the program.
 - Pre-Release Substance Abuse Program (PRSAP)
 - 351 offenders were enrolled in the program and 287 offenders completed the program.
 - Substance Abuse Felony Punishment Facility (SAFPF)
 - 1,494 probation offenders were enrolled in the program, and 1,338 probation offenders completed the program.
 - 146 parole modification offenders were enrolled in the program, and 161 parole modification offenders completed the SAFPF.
- DRIVING WHILE INTOXICATED PROGRAM – 254 offenders were enrolled 219 offenders completed the program at the East Texas Treatment Facility for males. There are currently 28 female offenders enrolled in the Halbert DWI Program.
- STATE JAIL SUBSTANCE ABUSE PROGRAM – 1,364 State Jail offenders have enrolled into the program, and 1,036 State Jail offenders have completed the program.

GENERAL ADMINISTRATIVE

- CIVIL COMMITMENT – 869 offenders were screened for Civil Commitment eligibility. The Multidisciplinary Team (MDT) met five times during this period (October 18 and 19, 2012, November 15 and 16, 2012, and December 13, 2012), reviewing a total of 176 offenders for civil commitment. Fifty (50) offenders were referred for expert assessments. Nine (9) offenders were civilly committed. Year to date stats for FY 2013 (September 2012-December 2012) are as follows: 1,094 offenders screened for eligibility, 247 offenders have been reviewed by MDT, 61 have been referred for expert assessment with 12 being civilly committed. A total of 284 offenders have been civilly committed since the process began on January 1, 2000.
- DEOXYRIBONUCLEIC ACID (DNA) TESTING – 5,699 offenders were DNA tested.
- GIVING OFFENDERS' KIDS INCENTIVE AND DIRECTION TO SUCCEED (GO KIDS)
 - 2,895 site visits to the GO KIDS website were recorded.
 - 18 phone calls, 4 emails were received.
- CHAPLAINCY DEPARTMENT
 - RPD Administration completed the Regional Chaplains Training started in the last quarter, with the training of Region IV and V unit chaplains. A total of 120 chaplains attended the training which covered ethics, leadership, management and policy updates.
 - The annual Crusade Provider's Meeting was held in Huntsville, Texas, to discuss the crusade schedule for 2013.
 - The Coalition of Prison Evangelist (COPE) Conference in Houston, Texas. This was an opportunity to network with potential Chaplaincy volunteers and provide training to 38 applicants.
- VOLUNTEER SERVICES
 - There were 59 training and orientation sessions held at regional locations accommodating 705 volunteer applicants or those needing to retrain. In addition, Volunteer Services held 9 special on-site training/orientation classes for a total of 297 volunteers.
 - Three hundred forty-two (342) volunteers used the retraining on-line feature to fulfill the two year retraining requirement.
 - The current number of agency-wide approved volunteers is *19,454
 - 1,602 applications received to include 830 received through the on-line application program.
*Decrease in number reflects the deletion of volunteers with no activity within the past two years.
- NEW VOLUNTEER PROGRAM PROPOSALS
 - 25 program proposals were received.
 - 21 proposals were approved and 4 are pending review.
- WRAPAROUND
 - One (1) WrapAround Resource Fair was held at Plane State Jail. There were 60 offender participants and 11 vendors who provided resources related to transitional and reentry services to the participants.

PROGRAM ACTIVITIES

- BABY AND MOTHER BONDING INITIATIVE (BAMBI) – Eight (8) mothers and 9 babies were enrolled in the program. Six (6) offenders successfully completed and discharged from Santa Maria.

- SERIOUS VIOLENT OFFENDER REENTRY INITIATIVE (SVORI) – There were 59 offenders parole voted that successfully participated in the program. There have been 695 offenders enrolled in Phase-I since the beginning of the SVORI program.
- SEX OFFENDER REHABILITATION PROGRAMS
 - Sex Offender Treatment Program (SOTP) 18R
 - 159 offenders were enrolled in the SOTP 18R with 36 successfully completing the program.
 - Sex Offender Treatment Program (SOTP) 9R
 - 59 offenders were enrolled in the SOTP 9R with 23 successfully completing the program.
 - Additional expansion of the SOTP-9R program is in the planning stages at the Beto and Neal Units.
 - Sex Offender Education Program (SOEP) 4R
 - 171 offenders were enrolled in the SOEP with 314 offenders successfully completing the program
- SUBSTANCE ABUSE TREATMENT PROGRAMS
 - In-Prison Therapeutic Community (IPTC)
 - 831 offenders were enrolled in the IPTC program and 695 offenders completed the program.
 - Pre-Release Therapeutic Community (PRTC)
 - 259 offenders were enrolled in the PRTC and 163 offenders completed the program.
 - Pre-Release Substance Abuse Program (PRSAP)
 - 363 offenders were enrolled in the program and 314 offenders completed the program.
 - Substance Abuse Felony Punishment Facility (SAFPF)
 - 1,453 probation offenders were enrolled in the program, and 1,331 probation offenders completed the program.
 - 82 parole modification offenders were enrolled in the program, and 144 parole modification offenders completed the SAFPF.
- DRIVING WHILE INTOXICATED PROGRAM – 249 offenders were enrolled 233 offenders completed the program.
- STATE JAIL SUBSTANCE ABUSE PROGRAM – 923 State Jail offenders have enrolled into the program, and 744 State Jail offenders have completed the program.

GENERAL ADMINISTRATIVE

- CIVIL COMMITMENT – 620 offenders were screened for Civil Commitment eligibility. The Multidisciplinary Team (MDT) met six times: January 17th and 18th, February 21st and 22nd, and March 21st and 22nd, reviewing a total of 213 offenders for civil commitment. A total of 58 offenders were referred for expert assessments. There were ten (10) offenders that were civilly committed. Year to date stats for FY 2013 (September 2012-March 2013) are as follows: 1,714 offenders screened for eligibility, 460 offenders have been reviewed by MDT, 119 have been referred for expert assessment with 22 being civilly committed. A total of 294 offenders have been civilly committed since the process began on January 1, 2000.
- DEOXYRIBONUCLEIC ACID (DNA) TESTING – 5,416 offenders were DNA tested.
- GIVING OFFENDERS' KIDS INCENTIVE AND DIRECTION TO SUCCEED (GO KIDS)
 - 2,776 site visits to the GO KIDS website were recorded.
 - 7 phone calls, 21 emails were received.
- CHAPLAINCY DEPARTMENT
 - Chaplaincy staff attended the National Correctional Industries Association, Religious Director Forum in Aurora, Colorado. This is a national training for chaplaincy administrators dealing with various non-traditional religious groups and how states are affected by the Religious Land Use and Institutionalized Persons Act of 2000.
 - Chaplaincy staff attended the Kairos State Board Meeting in Austin, Texas. Staff expressed the appreciation of the Agency for their volunteer efforts, and answered questions from the attendees.
 - Chaplaincy staff attended the American Correctional Chaplain Association (ACCA) Conference in Houston, Texas. Vance Drum, Region I Chaplain, was named President of this association.
- VOLUNTEER SERVICES
 - There were 59 training and orientation sessions held at locations in Correctional Institutions Division Regions 1-6. 949 volunteer applicants were trained/retrained. In addition, Volunteer Services held 10 special on-site training/orientation classes for a total of 229 volunteers.
 - 435 volunteers used the retraining on-line feature to fulfill the two year retraining requirement.
 - The current number of agency-wide approved volunteers is 19,671
 - 1,617 applications received to include 937 received through the on-line application program.
- NEW VOLUNTEER PROGRAM PROPOSALS
 - 79 program proposals were received.
- WRAPAROUND
 - Due to Lock Down on the Unit, a WrapAround Resource Fair was not held at Plane State Jail. The next Resource Fair is scheduled for April 22, 2013.

PROGRAM ACTIVITIES

- BABY AND MOTHER BONDING INITIATIVE (BAMBI) – 7 mother and 7 babies were enrolled in the program. 7 offenders successfully completed and discharged from Santa Maria.
- ADMINISTRATIVE SEGREGATION PRE-RELEASE PROGRAM (ASPP)
 - 177 participants enrolled in the program. 47 participants completed. There have been 325 offenders enrolled in the ASPP with 78 completions since the beginning of the program.
- SERIOUS VIOLENT OFFENDER REENTRY INITIATIVE (SVORI)

- 19 offenders parole voted that successfully participated in the program. There were 11 offenders accepted into the program as volunteers. Totaling 31 offenders entering the program. There have been 726 offenders enrolled in Phase-I since the beginning of the program.
- SEX OFFENDER REHABILITATION PROGRAMS
 - Sex Offender Treatment Program (SOTP) 18R
 - 48 offenders were enrolled in the SOTP 18R with 35 successfully completing the program.
 - Sex Offender Treatment Program (SOTP) 9R
 - 263 offenders were enrolled in the SOTP 9R with 41 successfully completing the program.
 - * Expansion at the Beto Unit started with an enrollment of the first 100 offenders.
 - * Hightower SOEP beds are in the processes of converting to SOTP 9R.
 - * Additional expansion of the SOTP-9R program at the Neal Unit is scheduled for April.

GENERAL ADMINISTRATIVE

- CIVIL COMMITMENT – 987 offenders were screened for Civil Commitment eligibility. The Multidisciplinary Team (MDT) met six times (April 18, 2013 and April 19, 2013, May 16, 2013 and May 17, 2013, June 20, 2013 and June 21, 2013), reviewing a total of 212 offenders for civil commitment. Fifty (50) offenders were referred for expert assessments. Thirteen (13) offenders were civilly committed. Year to date stats for FY 2013 (September 2012-May 2013) are as follows: 2701 offenders screened for eligibility, 672 offenders have been reviewed by MDT, 169 have been referred for expert assessment with 35 being civilly committed. A total of 306 offenders have been civilly committed since the process began on January 1, 2000.
- DEOXYRIBONUCLEIC ACID (DNA) TESTING – 7,806 offenders were DNA tested.
- GIVING OFFENDERS' KIDS INCENTIVE AND DIRECTION TO SUCCEED (GO KIDS)
 - 2,716 site visits to the GO KIDS website were recorded.
 - 6 phone calls, 2 emails were received.
- CHAPLAINCY DEPARTMENT
 - Chaplaincy staff attended a meeting with Prison Fellowship Ministry at the Crain Unit to discuss the implementation process for a new program; a meeting with Texas Baptist Men in Dallas, TX to discuss cooperation between volunteer groups and the agency and identify areas of improvement; a Kairos State Board meeting in Austin, TX to express appreciation of their volunteer efforts and identify areas of improvement; and with Discipleship Unlimited in Temple, TX to discuss the faith based dorm process and procedures.
 - Chaplaincy staff attended volunteer appreciation events at the following facilities to express our appreciation for their service and assistance in fulfilling the agency's mission: Crain Unit, Gist State Jail, Hughes Unit, Lopez State Jail, Segovia Unit, Tyler District Parole Office, and Wynne Unit.

GENERAL ADMINISTRATIVE

- CIVIL COMMITMENT – 1,143 offenders were screened for Civil Commitment eligibility. The Multidisciplinary Team (MDT) met nine times during this period (July 18 and 19, 2013, August 15 and 16, 2013, and September 4, 2013, September 13, 2013, September 19 and 20, 2013, and September 27, 2013), reviewing a total of 243 offenders for civil commitment. A total of 63 offenders were referred for expert assessments. During this time, there were twelve (12) offenders that were civilly committed. Year to date stats for FY 2013 (September 2012-August 2013) are as follows: 3511 offenders screened for eligibility, 816 offenders have been reviewed by MDT, 217 have been referred for expert assessment with 44 being civilly committed. A total of 318 offenders have been civilly committed since the process began on January 1, 2000.
- DEOXYRIBONUCLEIC ACID (DNA) TESTING – 7,323 offenders were DNA tested.
- GIVING OFFENDERS' KIDS INCENTIVE AND DIRECTION TO SUCCEED (GO KIDS)
 - 2,594 site visits to the GO KIDS website were recorded.
- CHAPLAINCY DEPARTMENT
 - Chaplaincy staff attended several volunteer events to express the Agency's appreciation for their services. The events included the Kairos State Board Meeting in Austin, TX; a banquet hosted by Less Than the Least Prison Ministry at the Sagemont Church in Houston, TX and the Huntsville Unit Volunteer appreciation. In addition, chaplain staff attended the faith based dorm graduation at the Formby State Jail.
 - Chaplaincy staff conducted Annual Chaplain's Training for Region III and Region IV chaplains. Information presented included comments from executive leadership, time management; various chaplaincy practices and procedures as well as updates in several areas related to correctional practices. The trainings for the remaining regions are schedule during the next quarter.
- VOLUNTEER SERVICES
 - There were 69 training and orientation sessions held at locations in Correctional Institutions Division Regions 1-6. 1,394 volunteer applicants were trained/re-trained. In addition, Volunteer Services held 10 special on-site training/orientation classes for a total of 437 volunteers.
 - 376 volunteers used the retraining on-line feature to fulfill the two year retraining requirement.
 - The current number of agency-wide approved volunteers is 21,675
 - 1,890 applications received to include 1,169 received through the on-line application program.
- NEW VOLUNTEER PROGRAM PROPOSALS
 - 82 Program Proposals were received. The majority of the new program proposals are faith-based however, programs in the following categories were also submitted: Anger Management, Substance Abuse, Family/Parenting Programming, Strengthening Relationships, and Job Skills.
- WRAPAROUND
 - The WrapAround Resource Fair was held at Plane State Jail on July 22, 2013. 114 offenders completed the WrapAround Application. Resources offered were the Windham School District programs, the Montrose Center, The AIDS Foundation of Houston, Service Employment Redevelopment Jobs for Progress and Goodwill of Houston.

A total of 202 offenders were reviewed. 18 offenders were referred for expert assessments. Ten (10) offenders were civilly committed. Year to date stats for FY 2015 (September 2014-March 2015) are: 2,253 offenders screened for eligibility, 476 offenders reviewed by MDT, 43 referred for expert assessment with 18 being civilly committed. A total of 376 offenders have been civilly committed thru March 2015 since the process began on January 1, 2000.
- DEOXYRIBONUCLEIC ACID (DNA) TESTING – 7,140 offenders were DNA tested.

A total of 404 offenders have been civilly committed since the process began on January 1, 2000.

GENERAL ADMINISTRATIVE

- CIVIL COMMITMENT – 934 offenders were screened for Civil Commitment eligibility. The Multidisciplinary Team (MDT) met three (3) times: On April 21-22, 2016 (two-day); May 19, 2016 (one-day); and June 16-17, 2016 (two-day). A total of 198 offenders were reviewed. 23 offenders were referred for expert assessments. Eight (8) offenders were civilly committed. Year to date stats for FY 2016 (September 2015 – June 2016) are: 3,811 offenders screened for eligibility, 807 offenders reviewed by MDT, 106 referred for expert assessment with 22 being civilly committed. A total of 412 offenders have been civilly committed since the process began on January 1, 2000.
- DEOXYRIBONUCLEIC ACID (DNA) TESTING – 6,347 offenders were DNA tested.
- GIVING OFFENDERS' KIDS INCENTIVE AND DIRECTION TO SUCCEED (GO KIDS) – 8,220 site visits to the GO KIDS website were recorded.
- CHAPLAINCY DEPARTMENT – RPD staff attended meetings with representatives of the InnerChange Freedom Initiative (IFI), Prison Fellowship and the Carol Vance Unit to discuss leadership changes and review current programming. . The Director of Chaplaincy and the Assistant Director of Chaplaincy presented at the annual South-Central conference of the American Correctional Chaplains Association in Arkansas. The presentation focused on Prison Culture Transformation and, the Role of Parole Chaplains. Discussions regarding the expansion of Kairos were held at the quarterly Kairos Board meeting in Austin. Currently Kairos has expanded to the Estelle and Terrell Units. During this period Thirty-three offenders (Class #2) graduated from the Southwestern Baptist Theological Seminary at the Darrington Unit; 26 were transferred as Field Ministers to six additional prisons, i.e., Robertson, Hughes, Stiles, McConnell Gibb Lewis, and the Clemens Unit, a total of thirteen Units. The Field Ministry program has received good reports. The Chaplaincy Faith-Based Dorm program for this quarter reports 7,053 beds on 82 units (up from 6,867 beds on 80 units from last quarter). Chaplaincy Department volunteers received 12 awards at the annual Governor's Volunteer Service Awards Ceremony. Regional Chaplains and the Director of Chaplaincy attended the annual Crisis Response Intervention Support Program (CRISP) training and meeting. The Department assisted in leading the annual Fallen Officers Memorial ceremony. The Department helped celebrate the 30,000th graduate of the Victims Services' Bridges to Life program.
- VOLUNTEER SERVICES – There were 83 volunteer training sessions held. There were a total of 1,831 volunteers trained/retrained. In addition 423 volunteers retrained online. There are 23,575 approved volunteers as of June 30, 2016.
- NEW VOLUNTEER PROGRAM PROPOSALS – 147 program proposal forms were received. Program areas included: Employment/Job Skills; Literacy/Education; Parenting; Reentry/Life Skills; Religious/Faith-Based; Victim Awareness; Substance Abuse; Support Groups; and Other.
- WRAPAROUND - The WrapAround Resource Fair was held at Plane State Jail on May 2, 2016 with 75 offenders completing the application. The following vendors participated in the resource fair: Angela House, which is a residential facility; Montrose Center of Houston, which offers counseling, addiction recovery support, and housing assistance; Peering for our Peers, which offers assistance in finding housing, resume writing, and referrals to community resources; and Women's Roots Transitional Living Home, which is a short term transitional home.

PROGRAM ACTIVITIES

A total of 196 offenders were reviewed. 27 offenders were referred for expert assessments. Eight (8) offenders were civilly committed. Year to date stats for FY 2016 (September 2015 – August 2016) are: 4,492 offenders screened for eligibility, 935 offenders reviewed by MDT, 125 referred for expert assessment with 27 being civilly committed. A total of 417 offenders have been civilly committed since the process began on January 1, 2000.
- DEOXYRIBONUCLEIC ACID (DNA) TESTING – 5,986 offenders were DNA tested.
- GIVING OFFENDERS' KIDS INCENTIVE AND DIRECTION TO SUCCEED (GO KIDS) – 6,601 site visits to the GO KIDS website were recorded.
- CHAPLAINCY DEPARTMENT – For this quarter, Faith Based Dorm beds increased from 7,241 to 7,426 and units increased from 85 to 89. The current number of Certified Volunteer Chaplain Assistants increased from 667 to 694. Chaplaincy attended the new chapel dedication at the Bradshaw Unit. Chaplaincy processed 266 new Program Proposal Forms in the last quarter (87% were approved). Chaplaincy processed 93 media requests for the quarter. The Southwestern Baptist Theological Seminary 2020 convocation was held at the Darrington Unit for incoming students of the seminary; the 66 field minister graduates (2015 and 2016) of the seminary remain active in addressing needs on the 13 units where they are deployed. Offender faith preferences this quarter have risen from 316 to 321 over the last quarter.
- VOLUNTEER SERVICES – There were 87 volunteer training sessions held. There were a total of 2,274 volunteers trained/retrained. In addition, 527 volunteers retrained online. There are 25,121 approved volunteers as of September 30, 2016.
- NEW VOLUNTEER PROGRAM PROPOSALS – 237 program proposal forms were received. Program areas included: Arts/Crafts; Employment/Job Skills; Literacy/Education; Medical Issues/Prevention; Parenting; Reentry/Life Skills; Religious/Faith-Based; Victim Awareness; Substance Abuse; and Support Groups.
- WRAPAROUND - The WrapAround Resource Fair, scheduled for July 25, 2016 at Plane State Jail, was cancelled due to unit lockdown. The next WrapAround event is scheduled for October 31, 2016.

- **CIVIL COMMITMENT TREATMENT PROGRAM** – Fifteen male offenders were enrolled in the Civil Commitment Program and 10 male offenders processed and transferred to Littlefield Texas Civil Commitment Center.
- **ADMINISTRATIVE SEGREGATION TRANSITION PROGRAM (ASTP)** - 24 offenders successfully completed the program. 34 offenders enrolled in the program. There have been 1,023 total enrollments since inception and 612 have completed the program.
- **ADMINISTRATION SEGREGATION DIVERSION PROGRAM (ASDP)** - 28 participants completed the program. Total since inception, 420 have completed the program.
- **CORRECTIVE INTERVENTION PRE-RELEASE PROGRAM (CIPP)** – Inclusive of the male and female sites there have been a total of 173 participants enrolled and 137 participants completed. Total since inception, 2,719 have enrolled and 1,955 have completed the program.
- **GANG RENOUNCEMENT AND DISASSOCIATION PROCESS (GRAD)** - 81 participants completed the GRAD process. Total since inception, 4,947 have completed the GRAD process.
- **SERIOUS VIOLENT OFFENDER REENTRY INITIATIVE (SVORI)** – 23 offenders successfully completed the program. 26 offenders were accepted into the program. There have been 1,081 offenders enrolled in Phase I since the beginning of the program. There is no waiting list.
- **OUR ROADWAY TO FREEDOM** – 100 clients enrolled (49 transfer facility and 51 jail confines). 54 Completed (31 transfer facility and 23 jail confines).

- **SEX OFFENDER REHABILITATION PROGRAMS** – Fourteen male and one (1) female offenders were enrolled in the SOTP 18R with twelve male offenders successfully completing. 192 male and five (5) female offenders were enrolled in the SOTP 9R with 193 male and two (2) female offenders successfully completing. 194 male and six (6) female offenders were enrolled in the SOEP with 158 male offenders successfully completing. There is no waiting lists for the SOTP-9, SOTP-18, or SOEP.
- **SUBSTANCE ABUSE TREATMENT PROGRAMS** - In-Prison Therapeutic Community (IPTC) - 855 male and 223 female offenders were enrolled in the IPTC program and 779 male and 228 female offenders completed the program. Pre-Release Therapeutic Community (PRTC) - 272 offenders were enrolled in the PRTC and 271 offenders completed the program. There is no waiting list. Pre-Release Substance Abuse Program (PRSAP) 584 offenders were enrolled in the program and 500 offenders completed the program. There are approximately 44 March specified offenders on the waiting list. Substance Abuse Felony Punishment Facility (SAFPF) – 1,180 male probation and 485 female probation offenders were enrolled in the program, and 1,040 male probation and 399 female probation offenders completed the program. 178 male and 29 female parole modification offenders were enrolled in the program, and 123 male and 24 female parole modification offenders completed the SAFP. There are 38 probation regular needs males (20 days waiting period); 43 probation special needs males (51 days waiting period); 7 probation special needs females (29 days waiting period); 4 parole special needs males; and 3 parole special needs females on the waiting list.
- **DRIVING WHILE INTOXICATED PROGRAM** – 424 (264 at East Texas Treatment Facility and 160 at Hamilton) male and 57 female offenders at Lockhart were enrolled; 329 male (219 East Texas Treatment Facility and 110 at Hamilton) and 48 female offenders at Lockhart completed the program.
- **STATE JAIL SUBSTANCE ABUSE PROGRAM** – 883 male and 135 female State Jail offenders have enrolled into the program, and 579 male and 112 female State Jail offenders have completed the program. (47 male and 0 female offenders completed the DWI Intervention classes; 14 male and 0 female offenders completed the Recovery Support Services)
- **FEMALE COGNITIVE PRE-RELEASE PROGRAM (FCPRP)** – Ninety-nine (99) participants currently enrolled in the program. Thirteen (13) participants are in the process of transition to the Marlin Unit to be enrolled in programming. The first graduation took place on February 24, 2017 with a total of seventeen (17) graduates. On March 20, 2017 our second class of eleven (11) participants successfully completed the program. There is no waiting list.
- **POST-SECONDARY ACADEMIC/VOCATIONAL PROGRAMS** – 1,620 College Interest Forms were received and processed. There were a total of 285 offenders transferred for Post-Secondary Education Services.
